Chairperson's Report

On behalf of the Directors of the Club I submit for your consideration the Annual Report and Financial Statements for the year ended 30 June 2019.

Financial reports.

For the financial year ended 30th June 2019, the Club made a profit of \$71,474, compared to \$8,059 for 2018, and losses for each of the proceeding 5 years.

Whist this is a much-improved result, we must be wary of becoming complacent. The profit of \$71,474 is underpinned by extra-ordinary items at \$25,441, leaving a normal profit of \$46,032. This figure of \$46,032 is further underpinned by significant contributions of volunteer labour and so should not be considered as a satisfactory long-term position. In fact, we have recently seen a decrease in the availability of volunteer labour, with a corresponding increase in paid wages.

Full copies of the audited financial reports for the year ended 30th June 2019 are available at the Club for perusal by members. They will also available to download from the Club's web site or from the Club's email newsletters. To save printing and postage costs, and as has been the practice in previous years, and as provided for by the Registered Clubs Act, only an abridged version of the accounts will attached to this Chairperson's Report when delivered by post.

Our Mission Statement.

The Bundanoon Club aims to provide a friendly, high-quality community facility, available for a wide range of activities and community groups. We will offer quality services underpinned by a transparent, accountable and profitable business practice to maintain long-term stability. We welcome the suggestions, ideas, and participation of our membership and the broader community. We will support local sporting, educational, cultural and social activities through profit sharing arrangements.

Board and Volunteers - Thanks.

Firstly, I would like to thank my fellow directors Steve Granger, Peter Cowling, Robert Hamilton, Melissa Ellsmore, Yvonne Boonham, Lee Borradale and Kevin Dale and to Scott Kelly and June Newman, both of whom served as directors for a few months during the year. I would like to particularly recognize Peter Cowling and Melissa Ellsmore, both of whom are discontinuing as directors due to family commitments.

We also need to thank the many people who volunteer their time, which enables us to keep our costs down.

Thanks to Supporting Organizations.

I would like to thank the Bundanoon Cricket Club, Bundanoon Bowling Club, Bundanoon Croquet Club, Bundanoon Tennis Club, Bundanoon Lions Club and Needles and Natter for the patronage of their members and for holding functions at the Club.

Daily Operations – Bar, Cleaning & Bistro.

I would like to thank our regular bar staff Alison Meindl, Katrina Ganger and Kristen Kellond for the great work they have done. Our focus is on friendly and efficient service and I believe they have delivered this very well.

Kirsten has also taken over the cleaning of the Club premises and has managed to maintain the excellent standard set by Yvonne and Dick Boonham, who carried on the task as volunteers for about 18 months since the Club reopened in 2017. Thanks to Yvonne and Dick.

The bistro remains a focus of improvement and I think we are starting to see the results in higher quality and more consistent quality food delivered. We again thank Arnie Fabiano and his excellent team of BJ, Connor and Chester.

Memberships.

Rebuilding membership back to about 500 currently, versus about 420 at the end of 2018. Our target is 800.

Redecorating.

The Board is looking to redecorate the Club in the next 12 months. Please refer to the end of this report for some proposed images. Although not finalized, we need to offer our thanks to Helen Stubbs for the production of these wonderful concepts.

Board and Volunteer - Opportunities:

In addition to the need to replace retiring board members, we have identified 3 keys roles that are critical to the future success of your Club. If these 3 roles are filled by people with the requisite skills and enthusiasm, we will see a significant difference to the prosperity and sustainability of your Club. Each role can be filled by one or more persons working as a team, and these people can fulfil the role as volunteers only, or preferably, as directors.

- "Functions and Events and Venue Hire". This role is primarily concerned with the promotion of, and taking bookings for, functions and events, but does not extend to running the functions and events, which is taken care of by the bar and bistro managers.
- "Advertising and Signage Sales". This role is concerned with the sale of advertising space within the Club, both on fixed signage around the greens and on television screens within the Club.
- "Grant Applications". There are numerous grants for which the Club may be eligible. We are seeking someone with the energy and expertise to apply for these grants.

Garden Planning and Maintenance.

It would be great if we had one or more volunteers, who were willing to the take responsibility for the gardens around the club. Primarily this means mowing lawns and pruning the hedges.

The Future.

The Club has certainly stabilized over the past 2 years, and whilst there is room for optimism, there is no room for complacency. We need the ongoing commitment, attendance and support of the members and the broader community.

Having said that, the board remains focused on improving the quality of our product. Our aim is for the Club to become a "venue of choice", rather than hoping the members will attend out of a "sense of obligation".



Polish and retain historical plaque.


Bollard lights running along both sides of driveway for safety.

Silver outdoor downlight.

"The Bundanoon Club" silver cut out letters on same timber as inside Club. Will need to varnish timber for outdoor use.

Plant a variety of native shrubs at entrance on both sides.

New Corporate colours for Bundanoon Club - Side Entrance and Car Park



Colourbond Dune with the "Texture Rock" Low Sheen finish on all exterior walls.

Downpipes to be painted in in Dune low sheen (no texture).

Horizontal and vertical railing on deck painted in **Colourbond Monument** low sheen. Stainless Steel cabling between top of handrail and base.

Repeat the look on the new handrail along the ramp leading to front door.

Window treatment of white roman blinds add to the clean modern feel and give some privacy in the hall.

Roof, sidepanel of roof, roof guttering, above windows and exterior columns painted in Colourbond Monument low sheen.



Dark Green/Grey Low sheen Paint above Bar area.

Typeface for wording is in Helvetica Regular silver 3D cut out.

Black bar counter top in Laminex or similar.

Bar facade in a light to mid real timber about 120cm deep applied horizontally. Panels have a gap of about 5mm between them showing black behind.

Black kick rail under bar.

Mid grey square format tiles about 30x30cm with lighter grey grout.

* Would suggest some spot lights in appropriate areas if budget allows.
